3. The applicant is expected to pay all expenses, including attorney fees, incurred by Guy Rents, Inc., for the enforcement of this agreement, as well as any collection costs incurred.
4. It is understood that proper jurisdiction and venue for any court or arbitration hearing shall be in Butte County, California.
5. It is understood that this application contains representations upon which the seller will rely in extending credit, and that all statements made by the applicant are true and correct as of the date on the application.
6. It is the responsibility of the applicant to notify Guy Rents, Inc., of the need for an authorized list of people allowed to charge on the account, and of any changes to that list by registered mail. Otherwise all employees and partners of the applicant will be authorized agents.
7. If any part of this agreement is unlawful, the remainder shall continue in full force and effect.
8. If requested by seller, the buyer will provide all information for the seller to send a preliminary twenty (20) day lien notice to protect sellers' rights to lien, stop notice and bond rights.
9. In the event that this agreement is executed by more than one person all undersigned persons will be responsible for the liabilities and obligations.
